School Description and Mission Statement (School Year 2020-2021)

Due to the COVID-19 pandemic and health & safety guidelines, all Sylvan Union schools started the school year with a distance learning platform, Sylvan SeLECT. This platform allowed students and teachers to continue a rich academic experience through multiple online platforms including Google Classroom and Google Meet. As COVID-19 positivity rates decrease as well as small groups and waivers are approved, groups of students were allowed to return to in-person learning with strict social distancing and safety protocols. While the 20-21 school year began like no other, the strong Sylvan foundation guaranteed a robust educational experience for all.

Coleman F. Brown Elementary opened its doors to educating children in grades Kindergarten through fifth grade in 1971. During the 2020-2021 school year, approximately 413 students were enrolled in transitional kindergarten through fifth grade. We believe that a child's education is fostered by the school and families working together to provide a learning experience where the students will excel. Our mission is to teach students how to learn, to help them gain knowledge, and to promote a positive self-image and growth in a culture of safety and respect. Utilizing district-adopted curriculum the staff employs the most effective teaching strategies along with grade level collaboration time to ensure the students are receiving quality instruction in all academic areas. Assemblies are a time when the entire school comes together to celebrate each other and accomplishments. Through the analysis of data and communication between staff members, students are provided with an educational experience that incorporates strong academic goals, physical education, comprehensive music and art programs, and the development of life-long character skills which will help develop our students into successful adults.

School Facility Conditions and Planned Improvements

Cleaning Process: During the 2020-2021 school year, COVID-19 cleaning and sanitation protocols were followed. Coleman F. Brown Elementary School strives to maintain a safe, healthy, nurturing and orderly school campus that encourages positive attitudes in students and staff. The district governing board has adopted cleaning standards for all schools in the district. Schools are on a regular cleaning schedule including wiping surface areas, being swept or vacuumed and the trash emptied. The cafeteria, gym, and all restrooms are cleaned daily. Grounds are groomed on a rotating basis with trash, lawn, and plumbing issues addressed as needed. Coleman F. Brown Elementary School was modernized several years ago and is in good shape. The site is maintained to the standards of the Sylvan Union School District.

Ramps for several portables were completely rebuilt. Bird damage to soffits has been repaired and the district is weighing options to prevent further damage. Coleman F. Brown is in good repair. All areas are clean and ready for daily learning activities.

School Safety Plan (School Year 2020-2021)

Coleman F. Brown Elementary School has adopted a comprehensive School Safety Plan that is reviewed and updated annually by members of the School Site Council. The Site Council is comprised of teachers, classified staff, parents, and the principal. The Safety Plan for the 2020-2021 school year was formally approved by the school's School Site Council on 2/10/2021. The school staff suggested final changes and had input on new assignments at the 1/25/2020 staff meeting. The revised Safety Plans are presented to the Sylvan Union School District Board of Trustees for annual review and approval. The Safety Plan is reviewed with staff members at the beginning of each school year with particular attention paid to emergency situations and staff and student responses. Safety drills, including fire, earthquake, and lock-down procedures, are held regularly. In addition, the school is inspected annually by the fire marshal and daily by the custodian. All issues discovered during these inspections are given the utmost priority. Copies of the comprehensive School Safety Plan are posted in each classroom and office area.
